From the Outdoor Range Officer

MAY 13TH THE RANGE WILL BE CLOSED FOR MAINTANCE FROM 9AM TO 5PM (plus or minus a couple of minutes.)

Here is the next installment of the range rules:

21. When ever a regularly scheduled match is in progress on any of the ranges there shall be no firing permitted on the immediately adjacent range. However, the Range Officer may allow a shooter to use the range on the opposite side of the indoor range building.
22. The executive Range Officer and Range Officers have total control of all range activities.
23. Vehicular travel on the range is restricted to existing roads only.
24. Put all trash in the provided trash cans.
25. Remove your targets when finished shooting and pick up your brass.
