NEWS AND NOTICES

ATTN: PISTOL SHOOTERS

Our club exists to provide a facility to safely enjoy the extremely fun and addictive hobby of shooting firearms. Surely we are all aware that we **MUST** be constantly vigilant and safety-minded to protect ourselves and others using the range, because of the extreme danger involved when firing firearms irresponsibly.

People are most often injured in firearm accidents because of ignorance or complacency on the part of the shooter. We can be ignorant if we don't have the proper training to be safe. (Take a hunter safely class) We can be complacent when we take our firearms and our range for granted, get too comfy and absorbed by our own activity, that we forget the basics of gun safety, and perhaps even forget to make certain that others at the range are not in harms way. We must remember that we as shooters are responsible for every projectile we fire.

On the upper level, east of the clubhouse, is the Benchrest 100 yard range (rifles only). Adjacent to and east of that range is the General Purpose/800 meter Range (open for rifles and pistols). Recently at the G.P. range, certain shooters, perhaps a bit complacent, short of training, or they left their common sense at home, set up steel targets about 20 feet from the firing line and with pistols com-

menced firing. Ricochets off those steel targets were flying over the heads of shooters "next door" on the Benchrest range and causing grave concern for their own personal safety.

If members wish to shoot steel at short ranges, I ask that it be done in the East Canyon pistol ranges where the orientation and high berms will reduce the risk of ricochets in unsafe directions. Such short range target practice on ricochet-prone steel at the more open General Purpose Range is really scary.

Having said that, I understand that there are organized matches shot on the G.P. range, where the whole point of the game is to knock over steel silhouettes with handguns. Those matches, however, are under the supervision of a Match Director who constantly monitors the safety of the match as it progresses. That is one of the reasons Club policy gives Match Directors control not only of the range were the competition is being held, but also those ranges adjacent to it.

Please remember that one of the basic safety rules is to know your target and what is beyond. If you are shooting steel you must be aware of the risk of ricochets, of where people are and how they may be affected. Be safe. - **Mike Freestone – President SJWF**
